If breathing is irregular or has stopped, effect mouth-to-mouth resuscitation and call a doctor.

# In the event of splashes or contact with eyes :

Wash thoroughly with fresh, clean water for 15 minutes holding the eyelids open.

# In the event of splashes or contact with skin :

Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner.

Watch out for any remaining product between skin and clothing, watches, shoes, etc.

If the contaminated aera is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.

# In the event of swallowing :

#### Always wash hands after handling.
